

Terms and Conditions for DCS Credit Card Promotion (the “Promotion”)

1. This Promotion is available from 19 January 2024 – 24 February 2024, or such other date(s) as may be determined and notified by DCS Card Centre Pte. Ltd. (“DCS”) at its sole discretion (the “Promotion Period”).
2. Under the Promotion, the successful applicant will be rewarded with an acquisition gift if he/she applies for any Eligible Card(s) with us during the Promotion Period.
3. For the purpose of the Promotion, an “Eligible Card” shall mean
 - i. Diners Club International Credit Card
 - ii. Diners Club International Charge Card
 - iii. DCS CASHBACK Credit Card
 - iv. DCS DON DON DONKI Credit Card
 - v. DCS Mustafa Credit Card
 - vi. DCS POPULAR Credit Card
 - vii. DCS Sheng Siong Credit Card
 - viii. DCS VICOM Credit Card
 - ix. DCS Ultimate Platinum UnionPay Card
 - x. DCS Ultimate Platinum Mastercard
4. For avoidance of doubt, the Eligible Card **does not include** DCS D-Lite Card and Imperium World Elite Card.
5. For new and existing DCS Cardholders, an applicant would be qualified to receive a one-off **S\$18.88 Ang Bao credited to their D-Vault Virtual Account**, if he/she:
 - (a) successfully applies for at least one (1) of the Eligible Card as the principal cardholder within the campaign period.
 - (b) activate D-Vault Account by entering their DCS Card number to add the card to the DCS Mobile App. A D-Vault tab will be generated instantly with their D-Vault account number.
 - (c) once the card have been added to the DCS App, S\$18.88 will be credited to the D-Vault virtual account.

6. DCS reserves the right to charge S\$18.88 as a transaction if :
 - (a) any of Eligible Card account applied within the campaign period is closed/terminated for whatever reason (whether by the applicant, DCS or otherwise) within the first twelve (12) months from the opening date of the Eligible Card account; or
 - (b) it is determined by DCS that the applicant has breached any of the terms and conditions relating to the Promotion, the Eligible Card account. In such cases, the applicant authorises DCS to debit the full value of the Activation Gift (as applicable) from any of the Eligible Card account.
7. Subject to the terms herein, the Cash credit shall be credited into applicant’s D-Vault account within two (2) months after the end of the Promotion.
