

SG60 Cash Rebate Campaign Terms and Conditions 2025

- The SG60 Cash Rebate Campaign ("**Promotion**") is valid from 2 July 2025 to 31 August 2025 (both dates inclusive) (the "**Promotion Period**").
- The Promotion is open to all Principal Cardholders ("**Cardholders**").
- By participating in the Promotion, Cardholders agree to be bound by these terms and conditions.
- The Promotion is valid for all DCS Personal Credit/Charge Cards, excluding DCS DeCard and D-Lite Cards.

Promotion Mechanics

- Receive a S\$60 Cash Rebate with every S\$1,500 in cumulative local currency spend during the Promotion Period.
- The Cash Rebate is awarded in blocks of S\$60, up to a maximum of S\$180 per Principal Cardholder during the Promotion Period.

Qualifying Spend in Local Currency (SGD)	Cash Rebate Earned
Minimum spend of S\$1,500	S\$60
Minimum spend of S\$3,000	S\$120
S\$4,500 and above	S\$180

- Local currency refers to transactions charged in Singapore Dollars (SGD).
- Only transactions posted during the Promotion Period will be considered for the eligibility of the Promotion.
- The Cash Rebate will be credited to the registered DCS Card by 31 October 2025.
- Any transaction reversals posted during the Promotion Period will affect the qualifying spend amount and may impact eligibility for the Promotion.

How to Participate

- To participate in the Promotion, Principal Cardholders are required to send an SMS composed in the following format: "**SG60<space>Last 4 digits of your DCS Card number**" to **8666 6362** from the mobile number registered with us ("**DCS Registered Mobile Number**").
- Each Principal Cardholder may register only one (1) Card, regardless of the number of Cards they hold.
- For avoidance of doubt, in the event of multiple SMS registrations by the Cardholder, only the latest SMS received by DCS will be taken as final.
- Only spend made with the registered Card (as evidenced by the last 4 digits of the DCS Card specified via the above SMS) will be considered for eligibility of the Promotion.
