

# Terms and Conditions Governing the DCS Flex Visa Platinum Card - Spend and Get Campaign ("Promotion")

#### **Promotion Period**

This Promotion is valid from 01 April 2025 to 31 May 2025 (both dates inclusive).

### **Eligibility**

- 2. This Promotion is offered to the Principal and Supplementary Cardmembers holding a DCS Flex Visa Platinum Card ("Cardmember") issued by DCS Card Centre Pte Ltd ("DCS").
- 3. To be eligible for the Promotion, the Principal Card Account must be valid (i.e. must not be suspended, cancelled or terminated), must be in good standing and must be conducted in a proper and satisfactory manner, as determined by DCS at its discretion (the "Eligible Cardmember").

#### **Promotion Mechanics**

- 4. Subject to the terms herein, the Eligible Cardmember will be entitled to receive additional 2% cash rebate ("Cash Rebate") (regardless of the Eligible Cardmember's chosen reward type as at 1 April 2025) on the eligible transactions when he/she charges a minimum spend of S\$2,500 to his/her Card ("Qualifying Spend") during the Promotion Period.
- 5. In addition, the Eligible Cardmember with the highest Qualifying Spend of minimum S\$3,000 during the Promotion Period ("**Top Spender**") will be entitled to receive a pair of limited-edition Nike x Tiffany & Co. Air Force 1 1837 sneakers (the "**Gift**").

#### **Qualifying Spend**

- 6. For the purpose of the Promotion, "Qualifying Spend" refers to retail transactions (including offline and online transactions) charged regardless of its posting currency through Visa Network, and:
  - a) are not under the list of Exclusions;
  - b) have a transaction date falling within the Promotion Period; and
  - c) have been successfully posted to the Card account within the Promotion Period.
- 7. Transactions made must be successfully captured by and posted within the Promotion Period. DCS shall not be responsible or liable for any delay in the transmission of any evidence of purchases by merchants or any other third party or for any non-fulfilment or delay in the payment of Cash Rebate. For illustration, if a transaction is made on 31 May 2025 and posted on 1 June 2025, this transaction would not be considered as Qualifying Spend under this Promotion.
- 8. For avoidance of doubt, DCS is entitled, for any reason and at any time, without liability, to rectify any errors in the computation of the Qualifying Spend, or otherwise adjust such computation as DCS may deem necessary.

#### **Exclusion**

- 9. Any of the following transactions shall not be deemed as Card Transactions and does not qualify to earn any Cash Rebate (collectively referred to as the "Exclusions"):-
  - (a) Annual fees
  - (b) Service charges and/or late payment charges
  - (c) All disputed charges unresolved as at DCS' processing date during the Promotion Period
  - (d) All adjusting entries during the Promotion Period
  - (e) Casino/access charges and/or cheque encashing charges
  - (f) Stolen/lost/fraud Card charges
  - (g) AXS bill payments

#### **Cash Rebate**

- 10. The Cash Rebate is capped at S\$60 for each Principal Card Account.
- 11. For the avoidance of doubt, any Card Transaction incurred by a Supplementary Cardmember shall accrue to the respective Principal Cardmember and form part of the Card Transactions eligible to receive the Cash Rebate.
- 12. The Cash Rebate is limited to one (1) redemption for each Principal Card Account.
- 13. The Cash Rebate will be credited to the eligible Principal Card Account within 2 months from the end of the Promotion Period (i.e. by 31 July 2025).
- 14. In the event of a refund and/or return amount, the amount will not be included for the purpose of calculating the Cash Rebate, and DCS reserves the rights to claw back the Cash Rebate if the refund occurs after the Cash Rebate has already been credited.
- 15. The Cash Rebate will not be awarded to the Eligible Cardmember if the Card Account is voluntarily, or involuntarily closed, terminated, or suspended for any reasons whatsoever before the Cash Rebate is awarded to the Cardmember.
- 16. The Cash Rebate awarded to the Eligible Cardmembers under the Promotion is strictly non-transferable and non-exchangeable for cash, credit, cashier's orders, reward points, other gifts or benefits, whether in whole or in part.
- 17. The Cash Rebate awarded will be in Singapore Dollars ("SGD"). All foreign currency denominated Qualifying Spend shall be converted to SGD at the prevailing foreign exchange rates as determined by DCS for the calculation of Cash Rebate to be awarded. For the avoidance of doubt, all foreign currency denominated Qualifying Spend on the Card will be subject to foreign currency transaction fees.

## <u>Gift</u>

- 18. The principal Top Spender who has (a) the highest Qualifying Spend of minimum S\$3,000 during the Promotion Period, and (b) fulfil the requirements set out in these terms and conditions will receive a pair of limited-edition Nike x Tiffany & Co. Air Force 1 1837 sneakers (the "Gift").
- 19. For the avoidance of doubt, in the event that any person entitled to the Gift is subsequently found to be ineligible for the Promotion, DCS shall not be obligated or liable to provide the Gift to another Eligible Cardmember.
- 20. The Top Spender who qualifies to receive the Gift will be notified latest by 31 July 2025. The Gift will be delivered to the Top Spender's mailing address registered with DCS.
- 21. The Top Spender is entitled to a maximum of one (1) Gift upon meeting the terms and conditions of this Promotion.
- 22. The Gift comes in shoe size US 9.5 only and there will not be any exchange, refund or replacement for size or for loss or damage.
- 23. The Gift is strictly not exchangeable for cash, loyalty redemption programme points, and/or other goods and services.
- 24. DCS reserves the right to substitute or replace the Gift with any item of similar value at its sole discretion without notice to any person.



25. Refunded or cancelled transactions will not count towards the Qualifying Spend and award of the Gift.

#### **General Terms and Conditions**

- 26. The eligibility of any Eligible Cardmembers to participate in this Promotion and/or receive any Cash Rebate and/or Gift under this Promotion shall be determined at the absolute discretion of DCS.
- 27. By participating in this Promotion, the Eligible Cardmembers consent under the Personal Data Protection Act 2012 to the collection, use and disclosure of the participating cardmember's personal data by/to DCS's agent or vendors and such other third party for the purpose of the Promotion and participating Cardmembers agree to be bound by the terms of DCS Privacy Policy, which can be found on https://dcscc.com/legal/privacy-policy.
- 28. DCS, its related corporations, employees and/or agents shall not be liable for any loss, injury, liability, expense or damage whatsoever or howsoever incurred or sustained by any Eligible Cardmember and/or any other person by reason of, arising from or in connection with the Promotion.
- 29. DCS reserves the right to vary, delete or add to any of these terms and conditions at any time from time to time or to withdraw, suspend or terminate the Promotion at any time without notice or liability.
- 30. DCS's decision on all matters relating to the Promotion shall be final, binding and conclusive.
- 31. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.
