

Dream Destination Travel Campaign Terms and Conditions 2024

- The Dream Destination Travel Campaign (**"Promotion"**) is valid from 26 February to 13 March 2024 (both dates inclusive) (the **"Promotion Period"**).
- The Promotion is open to all principal cardholders (**"Cardholders"**). By participating in the Promotion, Cardholders agree to be bound by these terms and conditions.
- The Promotion is valid for all DCS Personal Credit/Charge Cards, excluding DCS D-Lite Cards.

Promotion Mechanics

- Receive S\$100 Cash Rebate plus a pair of GOTRIP luggage with a minimum aggregated spend of S\$2,800 during the Promotion Period, in one or multiple transactions on Travel Bookings.
- Travel Bookings include transactions made directly at any Airlines, Hotels, Cruises, and Travel Agencies which fall under the following MCCs:

- Only transactions posted during the Promotion Period will be considered for the eligibility of the Promotion.
- Any reversals on transaction(s) posted during the Promotion Period will be considered in the accumulation towards the minimum aggregated spend.
- Each redemption includes S\$100 Cash Rebate plus a pair of GOTRIP luggage ("Gift") comprising a regular 24" suitcase in Steel Blue and a carry-on 20" suitcase in Pastel Yellow.
- Each Cardholder can only redeem the Gift once.
- The S\$100 Cash Rebate will be credited into the registered DCS Card by 30 April 2024.
- The GOTRIP luggage redemption letter will be mailed to the Cardholders' mailing address registered with DCS by 30 April 2024.

How to Participate

- To participate in the Promotion, Cardholders are required to send an SMS composed in the following format: "GOTRAVEL<space>Last 4 digits of your DCS Card number" to 8666 6362 from the mobile number registered with us ("DCS Registered Mobile Number").
- Only spend with the registered Card based on the last 4 digits of the DCS Card specified via SMS will be considered for eligibility of the Promotion.
- An acknowledgement of participation will be sent to the Cardholder's DCS Registered Mobile Number within one (1) working day.
- Only principal cards are eligible for participation in this Promotion.
- Cardholders whose current mobile number is different from DCS Registered Mobile Number are required to first update their mobile number with DCSCC before registering for the Promotion. Cardholders would not be eligible to participate should they register for the Promotion with a mobile number different from DCS Registered Mobile Number.
- For avoidance of doubt, in the event of multiple SMS registrations by the Cardholder, only the latest SMS received by us will be taken as final.
- Cardholders are only deemed to be qualified for the promotion upon receipt of the acknowledgment SMS from us.
- Limited only to the first 200 successful registered Cardholders.

 - Entrance and/ or subscription and/or renewal fees;
 - Service charges and/or late payment charges;
 - All disputed charges unresolved as at DCSCC's processing date of the monthly statement during the promotion period;
 - All debit and credit journal entries;
 - Casino/access charges and/or cheque encashing charges;
 - Stolen/lost/fraud Card charges;
 - AXS bill payments;
 - Road Tax payment;
 - All transactions at Land Transport Authority;
 - All transactions at Singapore Post;
 - 0% Interest-free Instalment Payment Plan (also known as BNPL, or Buy-Now- Pay-Later);

 - Balance Transfer;
 - Transactions made with Esso Fleet Card (EFC);
